## Scholarship/ Student Aid Fund for Indigent Student

### Introduction:

6. Initiation of measure to find out solutions to any grievances regarding scholarships.

#### **B. Student Aid Fund for Indigent Student:**

Every year after a short notification in the month of September, the applications are invited from the students who are poor, financially weaker and who has lost his/her father or mother. This application should be enclosed with valid documents like admission receipt, income certificate, ration card and death certificate of their either parents. These applications are scrutinized by a committee constituted by Hon. Principal and list of students availing the scholarship are then declared.

With the advent of this financial assistance, it has been found that students have done very well in their academic goals. This has resulted in incremental growth in the enrolment of the student.
